DIRECTIONS TO:

**Southcenter Corporate Square

FROM AIRPORT:

- Take Freeway entrance out of Airport
- Follow signs to I-5/I-405
- Enter onto WA518
- Stay in right lane
- In ½ mile take the exit to 51st Ave S / Southcenter Parkway
- Turn right when you come off the exit
- Go to the second stop light (**stay in the left lane**) and turn right onto Southcenter Parkway
- Go to the next stop light and turn left onto Strander Blvd
- Move to right lane
- At 3rd light turn right onto Andover Park W
- Go to Corporate Drive N – turn right
- Go to Building 4 Suite 101 (follow the office park map)

FROM I-5 NORTHBOUND:

- Travelling northbound on I-5
- Take Exit 153, Southcenter, off I-5 north
- When you come off the exit, turn right onto Southcenter Parkway S
- Move into left lane
- Continue on Southcenter Parkway S
- Turn left onto Minkler Blvd
- Go to Andover Park W turn left
- Go to Corporate Drive N – turn left. You are now in Southcenter Corporate Square, follow office park map.

FROM I-5 SOUTHBOUND:

- Travelling southbound on I-5
- Take exit 154B, Southcenter Blvd & Mall
- At the stop light when you come off the exit, turn left onto Southcenter Blvd
- Go to 61st Avenue South and turn right

- Go to the next stop light, Tukwila Pkwy and turn left
- Go to Andover Park West and turn right
- Continue on Andover Park West to Corporate Drive N and turn right. You are now in Southcenter Corporate Square, follow the office park map.

FROM VALLEY FREEWAY, 167, NORTHBOUND:

- Travelling northbound on Valley Freeway, 167
- Take the South 180th Street exit
- When you come off the exit, at the stop light, turn left
- You will be on South 180th St. Continue straight across So. 180th
- At Andover Park West – turn right
- Go to Corporate Drive N and turn left. You are now in Southcenter Corporate Square, follow office park map.

FROM SOUTHBOUND I-405:

- Travelling south on I-405
- Take Exit #1, Tukwila, West Valley Highway
- When you come to the stop light, turn right onto Interurban Ave
- Continue straight on Interurban Ave which becomes West Valley Hiway
- Go to Strander Blvd. and turn right
- Go To Andover Park West and turn left
- Go to Corporate Drive N and turn right. You are now in the Southcenter Corporate Square, follow the office park map.
